- Review of Fifth Third Bank data and information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions at Fifth Third Bank Cincinnati, Ohio headquarters office; and
- Audit of sample of data used by Fifth Third Bank and VIOX Services to determine GHG emissions.

Assurance Opinion:

Based on the process and procedures conducted, there is no evidence that the Scope 1, Scope 2, and Scope 3 GHG emissions assertion shown above:

- is not a fair representation of the GHG emissions data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Accounting and Reporting Standard s.

It is our opinion that Fifth Third Bank has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.
