At the same time, we consistently hear that investors, analysts, and IROs are increasingly facing the issue of what to do about ESG reporting – how to create a program around it, how to interpret the myriad ratings (which are not always consistent!), and how to build an investing platform centered on ESG.

An ESG framework has steadily gained traction in recent years. Adopted earlier internationally than in the U.S. – it's unclear whether the current wave of enthusiasm around ESG and impact strategies would have reached similar levels as quickly under different circumstances.

Had we not been sitting at home during a global pandemic, witnessing the events of the past few years, including (but not limited to) the #metoo movement,

2021 Guide to Effective Proxies:

In the current environment of Say on Pay, heightened shareholder activism and intensifying interest in ESG, human capital, and sustainability, clearly and credibly communicating these expanding yet inter-related stories through company proxy statements, annual reports, sustainability reports, and other channels is rapidly moving past a "nice to have" to an imperative. IROs can play a significant role in helping their companies clearly articulate

#blacklivesmatter, and volatile weather conditions driving an accelerated discussion around climate change, perhaps things would be different.

At NIRI, we wholeheartedly support greater transparency (hopefully leading to more significant action) into public companies' approach to ESG. At the same time, with multiple ESG disclosure methodologies in use and a continuously changing landscape as regulatory bodies (SEC, etc.) pay more attention, it is also challenging for IROs and ESG professionals (who are in high demand these days!). Even if we agree philosophically, the how and what of getting there is sure to be a bumpy ride.

In the hopes of addressing these concerns, NIRI NY will be hosting a virtual panel discussion on **Monday, November 15 (Peer-to-Peer: ESG Insights for IROs)**, with peer ESG experts aimed at helping our members navigate the alphabet soup of ESG and implement their corporate programs. We look forward to seeing all of you virtually to discuss this very topical and important subject.
