

## **Donaldson Company Engine Filter System Earns California Approval for Heavy-Duty Diesel Engine Retrofits**

MINNEAPOLIS--(BUSINESS WIRE)--Nov. 12, 2002--Donaldson Company Inc. (NYSE:DCI) today announced it has received Level 1 Verification from the California Environmental Protection Agency's Air Resources Board (ARB) for its Diesel Oxidation Catalyst (DOC) muffler and Spiracle(TM) crankcase ventilation (CCV) filter. The DOC muffler and Spiracle CCV filter combination dramatically reduces diesel engine emissions from the tailpipes and engine crankcase vents of medium and heavy-duty trucks and school buses. ARB approval enables Donaldson to sell the combination on a retrofit basis to help California vehicle operators meet state pollution control requirements and limit toxic diesel engine emissions. Donaldson's emission reduction systems can be used on the broadest family of engines, with the widest range of operating conditions, of any system granted approval and is the only system addressing both exhaust and crankcase emissions. This gives Donaldson the leadership position in an estimated \$100 million retrofit opportunity over the next five years.

"We are extremely pleased to receive ARB approval for our emissions-reduction system," said Steve Schmeichel, emissions general manager, Donaldson Company. "We've conducted extensive engine and field tests to confirm the performance and long-term durability of our products. This technology provides reliable, proven emission reductions at a competitive cost. We've created tremendous market interest with this product approach and expect to retrofit a significant number of trucks and buses in the next 12 to 18 months."

Under the ARB's Diesel Risk Reduction Plan (DRRP), approximately

- 1.25 million diesel engines in California are candidates for retrofitting with technology like the Donaldson DOC muffler and Spiracle CCV filter system. Such technology is designed to significantly reduce the emission of diesel particulate matter -- the black exhaust emitted by diesel engines. The combined DOC muffler/Spiracle CCV filter system reduces engine particulate matter emissions by 26 to 50 percent, meeting ARB Level 1 standards requiring greater than 25 percent reduction. To gain ARB approval, Donaldson Company completed rigorous engine and field tests to ensure the emission-reduction system met performance and durability requirements.

Donaldson is a leader in the emissions market and was the first and only company to develop and supply an active diesel trap system that was certified by both the U.S. Environmental Protection Agency (EPA) and the California ARB for urban bus applications in the late 1980s and early 1990s. Donaldson has since supplied more than 400,000 DOC muffler units for urban bus and medium-duty diesel applications. The company supplies approximately 100,000 DOC mufflers annually for major engine OEMs.

Donaldson DOC muffler and Spiracle products are available through many engine and heavy-duty truck dealers and distributors throughout California. Donaldson is pursuing similar verifications from the EPA for its Diesel Voluntary Retrofit Program. Both the DOC muffler and Spiracle CCV filter system have U.S. and international patents and patents pending.
